 - 1. Apparently, no rule against her handling tenure track evaluations
 - a. Medical School Dean is not tenure

 - vii. Split into different components to different people (Service person, Research person, Teaching person)

- c. Continued History of Decline
- d. Demographics of Decline
 - i. Freshman decline hopefully a COVID decline
 - ii. Transfer is down less
 - iii. CBC saw a 7% decline; concern about knock on effects.
- e. Possible use of Waivers for Blue Mountain Oregon.
 - i. There exists in-state tuition on some Columbia River Consortium for Ed Leadership
