- II. Update from Faculty Senate Exempt
 - a. Steven Holland indicates likely/hopeful about a 3.5% raise.

 - c. Faculty Senate will be forming a committee to analyze conflict of interests regarding Pullman Chancellor/Provost
 - i. Formed by president, not faculty senate.
 - ii. Currently composition is uncertain, not guaranteed to have other campus faculties.

 - d. UCORE DIVR Proposal
 - i. Not separate credits, possible alternative of DIVR to EQJS
 - ii. Voting will take place the week of the 15th.
 - iii. Not likely that double designation of DIVR and EQJS will exist.
 - e. Work on Accommodations
 - i. Who determines appropriate accommodations for students?
 - 1. Currently Access Center
 - a. Faculty are Concerns about the lack of qualifications
 - b. Consultations are not being done before accommodations are being offered.
 - c. Gretchen is also fielding some Pullman accommodations
